

TO ENSURE A SAFE, HAPPY & HEALTHY ENVIRONMENT FOR YOUR DOG & OTHERS

1) PROOF OF VACCINATIONS

Dog(s) must remain current on distemper, rabies & bordetella vaccinations. Proof of vaccinations must be provided prior to first stay and proof must be provided as each vaccination is updated. Vaccinations must be administered & recorded by a licensed veterinarian.

2) TICK & FLEA FREE

Dog(s) must be tick & flea free. Any dog found to have fleas or ticks will be treated immediately, on premises, with "Front Line" tick & flea preventative at owner's expense.

3) GOOD HEALTH

Dog(s) must be in good health. We reserve the right to refuse day care or boarding services to any dog.

4) ILLNESS OR INJURY

Should dog become ill or injured while in our care: Owner will be notified 1st. If not available, emergency contact will be notified 2nd. If not available, your dog will be transported to closest licensed veterinary care facility for care at owner's expense. As owner of said dog(s), I hereby give consent for emergency medical care as prescribed by licensed veterinarian.

5) DROP OFF & PICK UP

Owner agrees dog(s) will be dropped off no earlier than 6:30 am and picked up no later than 6:30 pm Monday – Saturday and on Sunday will be picked up no earlier than 10:00 am and no later than 3:00 pm. Dog(s) will not be released to anyone other than person(s) listed on this contract. Identification will be requested! Day care late pick up fee is \$ 10 per 15 min per pet. Any dog(s) in day care not picked up by 7 pm will be boarded overnight at our facility at owner's expense.

6) FEES

Owner agrees all fees are due & payable on date of service. Day care weekly rates are due Mondays and can only be used 5 consecutive days. (Monday-Friday) Day care monthly rates are due on the 1st day of the month and run through the last day of the month. No refunds or credits for days missed.

7) ABANDONMENT

Should owner/owners agent fail to pick up dog(s) from day care session at closing and fail to contact Dog Days Doggie Day Care & Boarding within 72 hours of initial drop off for day care session, dog(s) will be considered abandoned. Owner will be responsible for all fees incurred for care, transportation, placement &/or adoption of dog(s).

8) RELEASE

As owner of said dog(s), I hereby release Dog Days Doggie Day Care & Boarding, LLC its employees, dog owners, customers & visitors from any liability including but not limited to injury, illness, disease, escape, loss, theft, fire or death of my dog or myself, no matter the cause. I acknowledge & understand that every dog reacts differently and that animals by nature are unpredictable. Dogs may, without warning, bite or cause injury to people and other dogs. I acknowledge and accept exclusive and sole responsibility for these and all other risks and release Dog Days Doggie Day Care & Boarding, LLC of all liability, no matter the cause.
